#### **CORRESPONDENCE**

C1: NYS ACH payment of \$7,321.00 has been received. The projection for the 2011 Budget was \$7500.

C2: Chenango County payment of \$514.97 for Assessor laptop

C3: Brisben Fire District 2012 Budget (full budget copy at Board meeting)/Public Hearing notice. The amount to be billed to the Town of Smithville for 2012 will be \$940.84.

C4: FOIL request from Att'y Fertig's office re: Sulphur Springs Rd and Town Clerk response. Hwy Sup't Kinney explained that an entrance to this property using the old road been has been utilized since it was purchased by Mr. O'Connell.

C5: Update on Tax Cap Compliance Info: model Local Law to override the 2% cap. A local law would have to be passed to do this. The Town of Smithville would probably not be affected.

C6: Letter from Jim Reeves: complaint about new Town property not being mowed. Hwy Sup't Kinney said he had planned to brush hog the property, but the property has been wet. He will get to it when he can. Councilwoman Mohr asked if it was expected to look like the park lawn. Councilwoman Vanderweyde suggested just brush hogging the property and leaving it at that. A letter will be written to Mr. Reeves.

C7: Service Education, Inc: invoice for next year (an increase of \$150.) for Justice Court software.

C8: Vestal Town Clerk/NYS Liquor Authority: renewal notification of liquor licenses no longer needed to all areas of NYS, outside of the 5 boroughs of NYC.

C9: Letter from John & Nancy Alesi re: water washing out driveway on 122 Whitling Rd. Hwy Sup't Kinney has changed the pipe and re-dug the ditch but a telephone line in ditch prevents the spot from being dug any deeper. The ditch will only take so much water before it starts running down their driveway. It was suggested to put in another pipe further up the road to help take the excess water. The house is built below grade level which doesn't help. Supervisor Johnson asked the Highway Dept. to have the ditch re-dug.

C10: Letter from County Treasurer: NYS made math errors in sales tax calculations. The next checks to Towns will be reduced about 50% in order to correct the error.

#### **NEW BUSINESS**

NB1: consider personal request by Community Life Ministries to be added to Group annual rental rate (Sept. 1st to Aug 31<sup>st</sup>). Board will table the request since they were not present.

NB2: consider request by Lynn Brooks for addition of plaque at flag pole. The Board asked TC Owens to find some documentation that Bob Brooks donated the flag pole.

#### **OLD BUSINESS**

OB1: Report on Justice audit: Councilwomen Vanderweyde and Mohr were not able to conduct the audit before the Board meeting tonight, but it will be done shortly.

OB2: further Smithville Day Committee discussion; new applicant is Kerry Rogers. Supervisor Johnson asked Tim Hanna about co-chairing the event but he is not interested. Supervisor Johnson asked for

suggestions. Board members suggested asking Karen Wood, the other applicant, to chair the Smithville Day event. Supervisor Johnson will contact her.

OB3: Chenango County Delinquent Tax Dept: delinquent taxes of \$940.84 by Oct. 31st are due on new Town parcel. Assessor Keith Klein explained there will be no more tax bills as the status has been changed to a fully exempt parcel. Att'y Monaco has reviewed the paperwork and has counseled that in the end we will have to pay the bill. Councilwoman Mohr asked to have it stated in the minutes that any future purchases by the Town would require back real estate taxes to be paid. Supervisor Johnson said the amount could be taken from Contingency A1990.4 and asked for a Resolution authorizing payment. The following was brought forth:

RESOLVED to pay the Chenango County taxes and late fees for the newly acquired parcel of Town land (tax map # 202.-1-18.341) in the amount of \$940.84. Payment to come from Contingency A1990.4 and to be paid by Oct. 31st.

OB4: further action on lamp posts and TC rear door. There was no further action on the TC rear door. Town Clerk Owens will ask the SHS at their meeting on Saturday about a replacement for the wooden light post at the Community Center downed by wind this summer.

OB5: Further discussion on Genegantslet Fire Co. proposal to assume responsibility of the Smithville Center Fire District from the Village of Greene. No response has yet been received from Marcia Miller, Mayor of Greene. Councilwoman Mohr and Councilman Schultes are in favor of it, but the Public should be made aware of the proposal. It was suggested to hold a Public Hearing.

Genegantslet Fire Chief Bob Whitmore indicated the insurance rating will be the same (for homeowners insurance policies), the equipment is the same as Greene and so is the manpower.
