\*\*DISCUSSION: request NYSDOT safety survey on State Hwy 41 near intersect w/Round Pond Rd.\*\*

Comments from resident Mike Harrington included his recommendation to eliminate parking spaces in front of the apartment building across from Seeber's Tavern as there is no site distance for people coming down Round Pond and turning onto State Hwy 41. Concerns were also expressed about some of the drivers on Round Pond Rd being Senior Citizens and youth drivers. This problem was previously addressed many years ago but resulted in no action. Mr. Harrington does not have a problem with "motorcycle parking only".

Councilman Pollard suggested to further restrict parking on Water St. as well

Supervisor Heisler said it would be the responsibility of the Board to request a **safety survey** of NYSDOT. With the Bridge replacement coming in next year, it would be advisable to move forward with the request.

Councilman Pollard would like to incorporate Water St. in the review as well and asked who should be contacted to conduct such a survey.
