OB1) complaint of unkempt properties on Pearl St./Fred Wilcox Rd/

A letter of complaint from the Smithville Historical Society on Pearl St. property was submitted and ready by Supervisor Heisler. Since the Town Code Enforcement Officer was not present, Supervisor Heisler said he would take the letter to the Chenango County Code Enforcement Officer the next day as they have been handling this particular code complaint.

OB2)LED upgrade at the Town Barn, other Town Barn renovations. Nothing has been done on the town barn but the Hwy Sup't is still hoping to use the Highway personnelto help with the renovations. With the roof, it would be best to contract some if not all of it out even though workers would need to be paid prevailing wage. It was suggested to contact either Randy Hay or perhaps Fred Eaton to spec and bid the roof.

OB5) consider action on Records Destruction: Town Clerk Owens has received a quote of approximately \$125-\$135 to destroy 550 lbs of unused records she and Deputy Clerks McLaughlin and Buck have purged, catalogued and readied for destruction. The Records Room has been cleaned out and better organized. Roger's Service Center can come to destroy the records on Sept. 30<sup>th</sup>. The final cost will be calculated at the time of destruction depending of the weight of the records. Board members decided the cost to have a service come and destroy the records outweighed the cost of owning a commercial shredder.

Resolved to authorize shredding of previously catalogued records for destruction and to authorize Roger's Service Center, Binghamton NY to come on Sept. 30<sup>th</sup>, collect the records labeled as such and to shred them on site. The final cost will be calculated on the scheduled day but is expected to be between \$125-135.

OB6) consider action on the Road Preservation Local Law

Board members next discussed action on the Road Preservation Local Law. There were still two items of concern, namely the extent of the bond and who should hold it and the application fee which was part of the current Local Law but not part of the newer proposed Local Law.

After much discussion it was decided the contractor should obtain the bond from his insurance company pending an amount determined by the Highway Sup't. The proof of the bond would be held by the Highway Sup't until he cleared the road for normal use. The application fee would be re-inserted into the Local Law, the fee to be determined on an annual basis according to the Town's fee schedule. Town Clerk Owens will make the changes and send them to the Planning Board Chair. Another Public Hearing will need to be held. Section 3 # 2 "proof of a bond, the amount to be determined by the Highway Sup't depending on the road(s) to be used"

Section 5 "proof of bond and a non-refundable application fee as depicted in the Town of Smithville fee schedule" get wording changed send to Shane.

OB7) no new information from Frontier on support for Mitel system. The system was down for almost 2 days while Frontier did some updates. The problems appear to have self corrected but the system itself is still an annoyance.

Fred called the customer service line who put the Town's concerns in with a repair item # and gave the name of the company who works with repair service. There should be some resolution soon.

OB8) update on Emergency Action Plan: While the County Att'y indicated the EAP was weak in some areas, County 911 administrator Matt Beckwith said the proposed EAP plan does verbalize the chain of command in an emergency situation. The Board decided to go ahead and adopt the plan as submitted.

A Land Use agreement for Town land next to Post Office was brought up. This property has been considered as a place for Senior Housing but Supervisor Heisler said he would like to see a plan first before giving permission

to a land use permit. A long term lease to build Sr. Housing project was discussed. What would be the best use for the property? It would perhaps be better to sell the land so the Town would not be liable.

- R12) Supervisor's Report: submitted
  - Budget is close to Tentative status but a problem developed with the Oxford Fire District which sent the Town a proposed budget with a 21.9% increase. A letter from Supervisor Heisler is being sent to the Oxford Fire District saying that Smithville will not sign the proposed budget as is. Councilman Whitmore said the Town can do nothing and because of Mutual Aid, Oxford still has to respond to calls. The Town of Smithville can say they are in negotiations. Councilman Whitmore also feels the Town should not be in a 5 year contract with Oxford, but to try and contract with another fire district would be problematic. The Town of Preston gets serviced 85% of the time by ambulances from Norwich or alternative ambulance service. It was also mentioned the Greene ambulance service answers many of Oxford's calls. Board members said Supervisor Heisler should go ahead and mail the letter to Oxford. Supervisor Heisler will finish preparing the Tentative Budget and will file it with the Town Clerk by the Sept 30<sup>th</sup> deadline.
  - Sales Tax revenue is strong this year. Next revenue check will be in November and will cover the negative balance in the Highway.
  - Mirabito will sell the propane tanks on town property for \$500.Ea. They do not have the current fuel
    contract and there always seems to be a problem when tanks have to be switched each year due to
    awarding of fuel contracts.
