RESOLVED to approve the Preliminary Budget as the final ADOPTED budget for 2020.

HIGHWAY: Hwy Sup't Witkowski spoke of problems with the 2002 Volvo

- The 2002 Volvo is down and will cost \$11K+ to get back on road or Volvo will do whole engine overhaul for \$37K., with a 2yr warranty. What does the Board want to do? Witkowski feels we should look at 3.2% interest loan for a different truck.
- Supervisor Cammarata: without the rest of the paving there is \$102K for the remainder of the year; major equipment fund \$35K; building reserve fund \$64K
- Whitmore: let Volvo fix the motor and let it be good for 2 years
- Witkowski: that is probably the best decision. May be able to charge part this year and part next year.
- Ludwig: rebuild the motor
- Hwy Sup't Witkowski will call and talk with Volvo

There was no other business to come before the Board. Supervisor Cammarata declared the meeting adjourned at 7:37PM.
