RESOLUTION #38

BOND RESOLUTION DATED JUNE 21, 2021

BOND RESOLUTION OF THE TOWN OF SMITHVILLE, CHENANGO COUNTY, NEW YORK AUTHORIZING THE ISSUANCE OF \$273,000 SERIAL BONDS TO FINANCE THE PURCHASE OF MACHINERY AND APPARATUS FOR THE HIGHWAY DEPARTMENT.

Introduced by _Councilman Ludwig_ who moved its adoption, seconded by __Councilman Whitmore_.

BE IT RESOLVED by the Town Board of the Town of Smithville, Chenango County, New York (the "Town"), as follows:

- <u>Section 1</u>. The Town is hereby authorized to purchase machinery and apparatus to be used for constructing, reconstructing, repairing or maintaining Town improvements, including a 2022 Mack Highway Truck (the "Project") the cost of which is \$30,000 or more at an estimated maximum cost of \$273,000 and to issue an aggregate \$273,000 in serial bonds pursuant to the provisions of the Local Finance Law to finance the estimated costs of the aforesaid class of objects or purposes.
- Section 2. It is hereby determined that the maximum estimated cost of the aforesaid class of objects or purposes is \$273,000, said amount is hereby appropriated therefore and the plan for financing thereof shall be the issuance of not to exceed \$273,000 serial bonds (the "Bonds") or bond anticipation notes of the Town authorized to be issued pursuant to this resolution; PROVIDED, HOWEVER, that to the extent that any Federal or State grants-in-aid are received for such class of specific objects or purposes, the amount of Bonds to be issued pursuant to this Resolution shall be reduced dollar for dollar; and
- <u>Section 3</u>. It is hereby determined that the period of probable usefulness of the aforesaid class of specific objects or purposes is fifteen (15) years, pursuant to subdivision 28 of paragraph (a) of Section 11.00 of the Local Finance Law.
- <u>Section 4</u>. Pursuant to Section 107.00(d)(9) of the Local Finance Law, current funds are not required to be provided prior to issuance of the Bonds or any bond anticipation notes issued in anticipation of issuance of the Bonds.
- <u>Section 5</u>. The temporary use of available funds of the Town, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this resolution.
- Section 6. The Bonds and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law and the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the Town, payable as to both principal and interest by a general tax upon all the real property within the Town without legal or constitutional limitation as to rate or amount. The faith and

credit of the Town are hereby irrevocably pledged to the punctual payment of the principal of and interest on the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, and provision shall be made annually in the budget of the Town by appropriation for (a) the amortization and redemption of the Bonds and bond anticipation notes to mature in such year, and (b) the payment of interest to be due and payable in such year.

Section 7. Subject to the provisions of this resolution and of the Local Finance Law, and pursuant to the provisions of Section 21.00, 30.00, 50.00 and 56.00 to 63.00 inclusive of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the Bonds and any bond anticipation notes issued in anticipation of the issuance of the Bonds, and the power to sell and deliver Bonds providing for substantially level or declining annual debt service, is hereby delegated to the Town Supervisor, the chief fiscal officer of the Town.

Section 8. The reasonably expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this resolution shall be from the Town's General Fund. It is intended that the Town shall then reimburse such expenditures with the proceeds of the Bonds and bond anticipation notes authorized by this resolution and that the interest payable on the Bonds and any bond anticipation notes issued in anticipation of the Bonds shall be excludable from gross income for federal income tax purposes. This resolution is intended to constitute the declaration of the Town's "official intent" to reimburse the expenditures authorized by this Bond Resolution with the proceeds of the Bonds and bond anticipation notes authorized herein, as required by Treasury Regulation Section 1.150-2.

Section 9. The serial bonds and bond anticipation notes authorized to be issued by this resolution are hereby authorized to be consolidated, at the option of the Town Supervisor, the chief fiscal officer of the Town, with the serial bonds and bond anticipation notes authorized by other bond resolutions adopted by the Town Board for purposes of sale in one or more bond or note issues aggregating an amount not to exceed the amount authorized in such resolution. All matters relating to the sale of the Bonds, including the date of the Bonds, the consolidation of the Bonds and bond anticipation notes with other issues of the Town, and the serial maturity of the Bonds, are hereby delegated to the Town Supervisor, the chief fiscal officer of the Town.

Section 10. The validity of the Bonds authorized by this resolution and of any bond anticipation notes issued in anticipation of the Bonds may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the Town is not authorized to expend money; or
- (b) the provisions of law which should be complied with at the date of the publication of this resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or

(c) such obligations are authorized in violation of the provisions of the Constitution of New York.

<u>Section 11</u>. This resolution, or a summary hereof, shall be published in the official newspaper of the Town, together with a notice of the Town Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

Section 12. The Town Supervisor, as chief fiscal officer of the Town, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the Town to provide secondary market disclosure as required by Securities and Exchange Commission Rule 15c2-12.

Section 13. The Town Supervisor, as chief fiscal officer of the Town, is further authorized to sell all or a portion of the Bonds to the United States Department of Agriculture, Rural Development ("Rural Development") in the form prescribed in one or more financing, grant or similar agreements (the "Financing Agreements") between the Town and Rural Development; to execute and deliver on behalf of the Town one or more Financing Agreements with Rural Development and to execute such other documents, and take such other actions, as are necessary or appropriate to obtain financing from Rural Development for all or a portion of the costs of the expenditures authorized by this Bond Resolution, and perform the Town's obligations under its Bonds delivered to Rural Development and the Financing Agreements.

<u>Section 14</u>. The Town Board hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this resolution.

Section 15. This resolution is subject to permissive referendum pursuant to Article 7 of the Town Law of the State of New York and Section 35.00 of the Local Finance Law. The Town Clerk is hereby authorized and directed to, within ten (10) days of the adoption of this resolution by the Town Board, post and publish a notice in the manner and form prescribed in Article 7 of the Town Law. This resolution shall take effect thirty (30) days after its adoption or if a petition is filed pursuant to Article 7 of the Town Law, upon the affirmative vote of a majority of the qualified electors of the Town voting on the referendum.

NB4) Consider approval of storage shed for fuel tanks at Town Barn

- Supervisor Cammarata attempted to obtain 4 quotes to revamp or reconstruct a new storage facility for gasoline storage tanks. The following were quoted:
 - o Evon Construction 24x24 pole barn with concrete pad, frost protection \$48,690
 - o Rogers Construction: would not bid
 - o H&H Construction bid \$53,960
 - o Rich Barnes (underground electric only) \$9,500.
 - o Big Buildings: 24'x24' steel building 12'H delivered and installed \$9783.00 plus electric costs and if Hwy workers can do the concrete pad and Binghamton Overhead Door for the entry door.
- Councilman Whitmore said the Town Highway does not need a building, just poles and a roof. Supervisor Cammarata said he would go back and price just poles and a pavilion style roof.

OB1) update on Cincinnatus Lake Watershed Protection District

The new owner has filed for 503c tax exempt for the Watershed Protection District and Lake Association. Supervisor Cammarata will meet with the NYSDEC to try to delete the Watershed Protection District.

OB2) update on Spectrum contract: this has been signed and mailed to Spectrum.

OB3) historical sign for Hansmann's: Town Clerk/Historian Owens has been working with the Auwarter family to finish wording for the marker. They are almost at the finalization point.

OB4) update on waste oil burner: the electric is done, installation will be in July

OB5) continued discussion on dog enumeration, 2nd DCO: Continuing the discussion from May's meeting, Town Clerk Owens had met with the Town Clerk in Greene who used "DogEnumeration.com" with some success, and she has also spoken with the Town Clerk in German where a dog enumeration was conducted in 2016. The Town of Greene experienced an increase of about 200 dog licenses using the outside service. The Town of German used mailers in the January tax bills and experienced a significant increase in licensed dogs. Board members decided to further explore the options and to table discussion again.
