The purpose of the Public Hearing is to hear Public Comment on a proposed water system for the hamlet of Smithville Flats. The notice of Public Hearing was read by Town Clerk Owens and Supervisor John Cammarata declared the Public Hearing OPEN @ 6:35pm.

Presentation by Brendon Becker from Lamont Engineering: The Town of Smithville hired Lamont Engineering to do a study for the creation of a water district, to address the complaints of the hamlet water from private wells, to create a boundary for the district, to find a distribution source, (at this time and juncture proposed mostly on the east side of the hamlet or potentially south), and to test water samples of different wells within the hamlet. Limited results of the water testing were available with the worst water of the wells tested coming from the Post Office, the Town Hall and others in the immediate area. The Town Hall tested positive for coliform, iron.

The proposed system as it stands now would require 25K lineal feet of pipeline to run from a possible water source on the east hill to the hamlet area. It could cost \$5 million for distribution of the water, with probably \$700-\$900. per year cost for users of the water system. Debt cost could be potentially \$50-60K to the Town.

To help finance the construction of such a water system, Brendon Becker is proposing a 60% grant from NYS Environmental Facilities, 40% of which would be at 0% interest rate; other grant programs available including a USDA Rural Development grant program could also be available. An Ad Valorem tax could be added to the district residents.

Supervisor Cammarata opened the hearing up to questions. These are not done in order or in full as the taping mechanism for the meeting failed and the only available notes were taken on a computer by the Town Clerk.

<u>Supervisor Cammarata</u>: asked about homeowner's insurance for people living within the district—would their rates be affected?

Brendon Becker: homeowner's insurance rates would be lower.

<u>Supervisor Cammaarata</u>: asked about piping from the street to the house.

<u>Brendon Becker</u>: The stop is at the curb or "curbstop"; piping to the house is the homeowners responsibility. Meters would be installed either on a meter at the house or possibly in a Meter pit in the yard. A check valve would be available.

Resident Dave Curtis: What about gas wells?

<u>Brendon Becker</u>: Finding available water in an area where there are gas wells would have to be worked around. It can be a concern

Board member Butler brought up a couple other options for grant funding

Resident Dave Curtis: Is there an option to tie in to the system or not?

<u>Brendon Becker</u>: yes, there would be an opt out but there would be a debt service charge to the property owner.

Resident Dave Curtis: what about apartment houses?

Brendon Becker: it would have to be decided by the Town Board

Resident Dave Curtis: what would the water be filtered with?

Brendon Becker: hopefully chlorine which would not require a filtering system

Resident Dave Curtis: said he uses green sand and ultra-violet light in his apartment building located next to the General Store

<u>Barbara Vanderbundt</u>: Would GC Controls be in the district? The Iron and sulfur at her daughter's house is bad.

Brendon Becker: yes

<u>Board member Whitmore</u>: most people have conditioners of some sort. There are many Septic systems next to wells in the hamlet. He also commented that the replacement of the NYS bridge in the center of the hamlet started this whole project. There might come a point when the Town would be forced to put in a water system. There is a safety issue as well.

<u>Fred Heisler</u>: asked about the funding process which could end up costing more than the proposal. What about the tax cap?

Brendon Butler: tax cap does not apply to the special district.

<u>Board member Butler</u>: The Town can always use stopping points along the way if the financial steps do not fall in line.

<u>Brendon Becker</u>: there are certain steps the Board would have to take tonight if they are willing to follow through with the water system. They are as follows:

- 1.) SEQR project: no contests. Need negative declaration Resolution. An initial environmental review was done with no negative responses there. This authorizes John to sign and pass the Negative Declaration
- 2.) Create the hamlet water District based on the map currently on display. Any costs incurred would be placed on taxpayers. Properties not located within the district can be involved in the district.
- 3.) Bond Resolution to sign authorizing the Town Board to bond up to \$8 million

SEPTIC COMPLAINT:

Town Clerk Owens has received a septic complaint from Lynne Conklin 2053 County Rd 2 regarding her next door neighbor's septic system. Over the years Mrs. Conklin claims the septic at 2063 County Rd 2 (immediately next door) has leaked out onto her property. The house at 2063 County Rd 2 burned in December 2021 and there is nothing there now except a slab. The property has less than 2 acres and is currently for sale. Additionally, the property at 2063 County Rd 2 has a right-of-way driveway as that property belongs to Mrs. Conklin.

Protocol for a septic complaint according to the Local Law for Sanitary Regulations # 1 (1989) is to present it before the Town Board who has the authority to request the Ordinance Officer to run a test of the septic system to see if it is functioning properly. Town Board members discussed the complaint but noted that

since there is currently not a structure at 2063 County Rd. 2, an evaluation of the septic system could not take place. Their advice was to wait and see what action is taken once the property is sold. If new owners would like to build on it, they would have to do a site plan review and appear before the Planning Board for permission to build. At that time Mrs. Conklin's complaint would have to be addressed.

BANNERS: Board member Whitmore and Jane Whitmore have identified 26 banners they feel would be appropriate for the electric poles in the hamlet of Smithville Flats; 13 of these would be American flags, 13 would be holiday related. The cost of the 26 banners plus the hardware to install them comes to \$4,471.51, the purchase to be made from The Flag and Banner company. There was discussion as to financing the cost of the purchase. Donated funds in the amount of \$825, have been received but the cost is also eligible to be used under ARPA funds. Board members decided to pay it fully from ARPA funds.

At a meeting of the Town Board of the Town of Smithville, Chenango County, New York held at the Town Hall located at 5285 NYS Route 41, Smithville Flats, New York 13841 on September 7, 2022, the following resolution was offered by Board member Whitmore, who moved its adoption, seconded by Board member Butler

RESOLUTION ESTABLISHING THE SMITHVILLE WATER DISTRICT NO. 1

WHEREAS, a meeting of the Town Board of the Town of Smithville, Chenango County, New York (the "Town") was held on September 7, 2022 regarding the establishment of the Smithville Water District No. 1 (the "District") pursuant to Article 12-A of the Town Law; and

WHEREAS, a map, plan and report (the "Maps and Plans") relating the establishment of the District, have been prepared by a licensed engineer and been filed with the Town Clerk in accordance with the requirements of Article 12-A of the Town Law; and

WHEREAS, the establishment of the District will include the construction of approximately 23,500 linear feet of water main piping in addition to new municipal wells and a new water treatment plant; and

WHEREAS, the boundaries of the District are set forth in the attached Exhibit A; and

WHEREAS, the Maps and Plans state that the proposed project shall provide water service to the Hamlet of Smithville Flats, which presently relies entirely on individual wells; and

WHEREAS, on July 18, 2022, the Town Board adopted a resolution scheduling a public hearing; and

WHEREAS, the resolution called a public hearing to be held on September 7, 2022 at 6:30 p.m. to hear all persons interested in this matter and to take action as required by law; and

WHEREAS, the resolution was published and posted as required by law; and

WHEREAS, a public hearing on the matter was held by the Town Board on September 7, 2022 at 6:30 p.m. and the matter was fully discussed and all interested persons were heard; and

WHEREAS, the Town proposes to acquire, construct and install a municipal water system in the District to serve homes that are not presently adequately served, including water mains, municipal wells, and a municipal water treatment plant, together with all equipment, machinery or apparatus and land or rights required in connection therewith (the "Project"), all as more particularly described in the Maps and Plans; and

WHEREAS, the maximum amount proposed to be expended for the Project will be \$8,000,000.00; and

WHEREAS, there will be no hook-up fees charged by the District for connections during the construction of the improvements, however, a typical user will have to spend approximately \$2,500 to abandon an existing water system and connect to the new municipal water system; and

WHEREAS, the cost of the proposed District to the typical property in the area in the first year following formation of the District (or, if greater, the first year in which both principal and interest on indebtedness and operation and maintenance costs will be paid) is estimated to be \$911,00; and

WHEREAS, the proposed method of financing the costs of the Project consists of the issuance of bond anticipation notes and serial bonds of the Town to mature in annual installments over an estimated term of 40 years, payable in the first instance from assessments levied on benefited real property in the proposed District; and

WHEREAS, the cost of the Project and related debt service will be assessed by the Town Board in proportion as nearly as may be to the benefit which each lot or parcel in the District will derive therefrom; and

WHEREAS, the Maps and Plans describing the foregoing, including a detailed explanation of how the estimated cost of the District to the typical property was computed, have been filed in the Town Clerk's office and are available for public inspection during regular business hours.

NOW, THEREFORE, the Town Board of the Town of Smithville hereby resolves and determines that:

- 1. The notice of hearing was published and posted as required by law and is otherwise sufficient.
- 2. All the property and property owners within the proposed District are benefited thereby.
- 3. All the property and property owners benefited are included within the limits of the proposed District.
 - 4. The establishment of this District is in the public interest.

IT IS FURTHER RESOLVED AND DETERMINED that the establishment of the District and the acquisition, construction and installation of the proposed water system improvements therein are in the public interest and will not constitute an undue burden on the property which will bear the cost thereof.

IT IS FURTHER RESOLVED AND DETERMINED that the establishment of the District is hereby approved and that the proposed acquisition, construction and installation of a

water system in the District, including pipes and pumps, together with all equipment, machinery or apparatus and land or rights in land required in connection therewith, all as more particularly described in the Maps and Plans, shall be acquired, constructed and installed when the required funds are available and provided therefor.

IT IS FURTHER RESOLVED AND DETERMINED that this District shall be known as the Smithville Water District No. 1 and shall be bounded and described as set forth on Exhibit A attached hereto.

IT IS FURTHER RESOLVED AND DETERMINED that the cost of the Project, including legal and engineering fees, and all other costs and expenses, shall be financed by the issuance of serial bonds and bond anticipation notes of the Town containing such terms as may be determined by the Town Board, and such costs shall be assessed by the Town Board in as close a proportion to the benefit to which each lot or parcel will derive from the Improvement as is possible.

IT IS FURTHER RESOLVED AND DETERMINED that this resolution is subject to permissive referendum as provided in Town Law Section 209-e, in the manner provided in Article 7 of the Town Law.

BOND RESOLUTION DATED SEPTEMBER 7, 2022

BOND RESOLUTION OF THE TOWN OF SMITHVILLE, NEW YORK, AUTHORIZING THE ISSUANCE OF \$8,000,000 SERIAL BONDS TO FINANCE THE COST OF TOWN OF SMITHVILLE, SMITHVILLE FLATS WATER DISTRICT IMPROVEMENTS.

BE IT RESOLVED by the Town Board of the Town of Smithville, Chenango County, New York, as follows:

Section 1. The Town of Smithville, New York (the "Town") hereby approves the acquisition, construction or reconstruction of or addition to Town of Smithville, Smithville Flats Water District, including, but not limited to, a new water treatment plant and distribution piping, including buildings, land or rights in land, original furnishings, equipment, machinery or apparatus, or the replacement of such equipment, machinery or apparatus required in connection therewith, is hereby authorized at an estimated maximum cost of \$8,000,000.

Section 2. It is hereby determined that the maximum estimated cost of the aforesaid specific object or purpose to be financed by the Town is \$8,000,000, said amount is hereby appropriated therefor and the plan for the financing thereof shall consist of the issuance of \$8,000,000 in serial bonds (the "Bonds") of the Town which are hereby authorized to be issued pursuant to this resolution and the provisions of the Local Finance Law; PROVIDED, HOWEVER, that to the extent that any Federal or State grants are received for such specific objects or purposes, the amount of Bonds to be issued pursuant to this Resolution shall be reduced dollar for dollar.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is forty (40) years pursuant to subparagraph 1 of Section 11.00(a) of the Local Finance Law. The proposed maturity of the Bonds will be in excess of five years.

Section 4. Pursuant to Section 107.00(d)(3)(a) of the Local Finance Law, current funds are not required to be provided prior to issuance of the Bonds or any bond anticipation notes issued in anticipation of issuance of the Bonds.

Section 5. The temporary use of available funds of the Town, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this resolution.

Section 6. The Bonds and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law

and the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the Town, payable as to both principal and interest by a general tax upon all the real property within the Town without legal or constitutional limitation as to rate or amount. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. There shall annually be apportioned and assessed upon the several lots and parcels of land within the Town of Smithville, Sewer District #1, which the Town Board shall determine and specify to be especially benefited by the capital purpose described in Section 1 of this resolution, an amount sufficient to pay the principal of and interest on the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, as the same becomes due and payable, but if not paid from such source, all the taxable real property in the Town shall be subject to the levy of ad valorem taxes without limitation as to rate or amount sufficient to pay the principal of and interest on such obligations.

Section 7. Subject to the provisions of this resolution and of the Local Finance Law, and pursuant to the provisions of Sections 21.00, 30.00, 50.00 and 56.00 to 63.00 inclusive of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the Bonds and any bond anticipation of the issuance of the Bonds, and the power to sell and deliver the Bonds and any bond anticipation notes providing for substantially level or declining annual debt service, is hereby delegated to the Town Supervisor, the chief fiscal officer of the Town.

Section 8. The reasonably expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this resolution shall be from the Town's General Fund. It is intended that the Town shall then reimburse such expenditures with the proceeds of the Bonds and bond anticipation notes authorized by this resolution and that the interest payable on the Bonds and any bond anticipation notes issued in anticipation of the Bonds shall be excludable from gross income for federal income tax purposes. This resolution is intended to constitute the declaration of the Town's "official intent" to reimburse the expenditures authorized by this resolution with the proceeds of the Bonds and bond anticipation notes authorized herein, as required by United States Treasury Department Regulation 1.150-2.

Section 9. The serial bonds and bond anticipation notes authorized to be issued by this resolution are hereby authorized to be consolidated, at the option of the Town Supervisor, the chief fiscal officer, with the serial bonds and bond anticipation notes authorized by other bond resolutions previously or heretofore adopted by the Town Board for purposes of sale in one or more bond or note issues aggregating an amount not to exceed the amount authorized in such resolutions. All maters regarding the sale of the bonds, including the dated date of the bonds, the consolidation of the serial bonds and the bond anticipation notes with other issues of the Town and the serial maturities of the bonds are hereby delegated to the Town Supervisor, the chief fiscal officer of the Town.

Section 10. The Town is hereby authorized to execute and deliver in the name and on behalf of the Town a project financing agreement prepared by the New York State Environmental Facilities Corporation ("EFC") (the "SRF Project Financing Agreement"). The Supervisor and the Town Clerk and all other officers, employees and agents of the Town are hereby authorized and directed for and on behalf of the Town to execute and deliver all certificates and other documents, perform all acts and do all things required or contemplated to be executed, performed or done by this resolution or any document or agreement approved thereby, including, but not limited to, actions related to the transaction with the SRF Project Financing Agreement.

Section 11. The validity of the Bonds authorized by this resolution and of any bond anticipation notes issued in anticipation of the Bonds may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the Town is not authorized to expend money; or
- (b) the provisions of law which should be complied with at the date of the publication of this resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or

(c) such obligations are authorized in violation of the provisions of the Constitution.

Section 12. This resolution, or a summary thereof, shall be published in the official newspapers of the Town for such purpose, together with a notice of the Clerk of the Town in substantially the form provided in Section 81.00 of the Local Finance Law.

Section 13. This resolution is not subject to a permissive referendum in accordance with Section 35.00(b)(2) of the Local Finance Law.

Section 14. The Town Supervisor, as chief fiscal officer of the Town, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the Town to provide secondary market disclosure as required by Securities and Exchange Commission Rule 15c2-12.

Section 15. The Town Board hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this resolution.

Section 16. This resolution shall take effect immediately.
